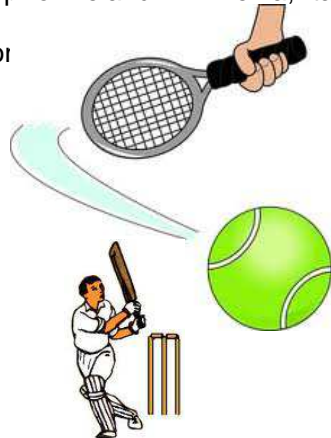

Hosts must sign a contract saying they will offer the products at the prices set by Booker all day, every day and display posters and PoS to support the deals.

The 'Buzz Bar' scheme lets licensees offer brands to customers at low prices while still making a minimum 50% GP per product!

Booker plans to roll out the scheme further. The inaugural promotion sets the selling price of 8 products as follows; bottles of Carlsberg Export, Coca-Cola and 25 ml shots of Sourz are £1; a 25 ml shot of Smirnoff is £1.25; a 25ml shot of Jack Daniel's is £1.50; a 568ml bottle of Bulmers is £2; a bottle of Peroni lager is £1.50 and 187ml bottles of Blossom Hill are £2.50. Each offer will consist of 8 drinks and run for 8 weeks.

## MAKING MACHINES LESS MYSTERIOUS!

***Machine didn't payout ? If a machine does not pay out a player, or short-pays them - Don't Worry!***

In every genuine case the machine will show an 'I.O.U' message so that will enable you to confirm the claim before you payout - it is usually best to pay the customer and keep them happy and our engineer will repay you when he comes to repair the fault.

**There are several simple explanations: So what could be wrong?**

- It could be that a coin has 'twisted' and blocked payout
- Or if the machine has a note acceptor and many notes are paid & played in, it doesn't allow the hopper/float to top up with £1coins to have funds to pay out, so it may be 'empty' of coin.
- The same kind of thing can be happen if a player pays in lots of silver coins - the machine won't have been able to top up its hopper/float with £1coins to payout - again it will be 'empty'.
- Less commonly, coins paid & played in to the machine may 'route' incorrectly. Occasionally coins may fall into the till instead of the hopper/float.

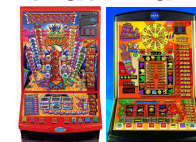

## EARN MORE MONEY...FOR FREE!

If you only have 1 machine - when a player wins the jackpot they will assume that another win is not likely and will stop playing. If you have another machine next to it, they are likely to move onto that one and continue to play - **increasing your revenue!**

You are probably aware that your [Alcohol] Premises Licence automatically entitles you to provide up to 2 fruit machines [as long as you have notified the local authority, see page 7 for details]. If you choose to have a 2nd machine installed it should be a 10p play £5 jackpot - this type attracts no AMLD licence duty.

## CIGARETTE MACHINE BAN - 1st October

**Cigarette vending machines will be removed from all pubs after top judge backs ban**

Cigarette vending machines will be removed from pubs, clubs and restaurants after the top judges yesterday upheld a Government ban.

The measure, drawn up by the Department of Health to combat under-age smoking, will come into force in October.

Tobacco industry chiefs said it would 'abruptly and entirely eliminate' the vending industry, costing at least 550 jobs.

Wolverhampton-based Sinclair Collis Ltd – which owns about 20,000 machines – had argued in the Appeal Court that the ban would encourage illicit tobacco trade and amounted to a violation of its human rights and European free trade rules

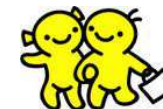

## ON ME' 'HEAD!



If you help run a local sports club, i.e the kid's football team, tennis club or other organised sports activity, you may be interested to learn that you can apply to HMRC to be treated as a registered community amateur sports club, or CASC.

If your club fits the following criteria there are a number of significant tax exemptions.

The main qualifying conditions are:

- The club must be open to the whole community,
- The club's main purpose must be to provide facilities for eligible sports, and to encourage people to take part in them,
- The club must be organised on an amateur basis.

The club must also be able to show that:

- It is set up and provides this facilities in an eligible area,
- It is managed by a fit and proper persons.

The corporation tax relief's that you can expect if you do register exempt the following sources of income:

- Trading profits, if the turnover is no more than £30,000 per year (if turnover is more than £30,000 all trading profits are taxable),
- Income from letting property, if the rent is no more than £20,000 per year (if letting income is more than £20,000 no exemption is possible), Any interest your CASC gets, Any capital gains it makes, Any GiftAid donations.

Additionally you may qualify for relief from non-domestic rates. In England, Wales and Scotland this amounts to 80% rates relief. Contact your Local Authority finance department to apply.
